Deposit/Payment Information

A reservation deposit of 50% of the planned event cost is required to reserve your date.

The remaining amount is adjusted, if necessary, and is due 14 days prior to the event, along with a damage deposit of \$200. Adjustments may include change in event type, total attendance count, and services or items to be provided.

If you cancel before 90 days prior to the event, we will refund 50% of your reservation deposit. If you cancel within 90 days of the event, none of the reservation deposit will be refunded to you, and no additional payment is required.

The damage deposit will be returned to you within two weeks after your event. If there are no missing items or damages assessed to any Cedar Ridge property or equipment, the damage deposit will be returned in full. This damage deposit only pertains to items owned by or rented from Cedar Ridge.

Catering

Caterers must be approved by Cedar Ridge, and hold the correct licensing with the State of Indiana. Generally, they are contracted to supply all of your table service, non-alcoholic beverages, and to bus the food related items from tables. Caterers are not permitted to supply alcoholic beverages unless by special arrangement.

Bar Service

Cedar Ridge offers bar service that includes beer and wine only. We must know at least 35 days in advance of an event to acquire the correct licensing. Licensing regulations do not allow us to serve liquor. Guests who are known or thought to be intoxicated will not be served alcoholic beverages. The law forbids anyone under 21 years of age to consume alcoholic beverages. All alcohol must be provided and served by Cedar Ridge. No other alcoholic beverages are allowed to be brought onto the premises.
